2. If your application is filled out correctly, the Regional District will send you a mail ballot package once we have received the ballots.

Following receipt of the mail ballot, you are responsible for ensuring that your completed ballot is received at the Regional District Office **no later than 4:30 pm on October 19, 2018 or by 8 pm on General voting day, Saturday, October 20, 2018 at the polling station for the Electoral Area in which you are voting.**

- A Canadian citizen;
- A resident of the Electoral Area for at least 30 days prior to voting day (September 20, 2018) **OR** a non-resident registered owner of real property in the Electoral Area for at least 30 days prior to voting day (September 20, 2018);
- A resident of BC for at least 6 months prior to voting day; (April 20, 2018);
- Not disqualified by law from voting in an election or otherwise disqualified by law.

I further declare that I am entitled to vote by mail for the following reason(s) (check at least one):

- I have a physical disability, illness or injury that affects my ability to vote at another voting opportunity for this election, and/or;
- I expect to be absent from the Regional District area at the time of advance voting October 10, and on general voting day October 20;
- I reside in East Gate Manning Park of Electoral Area 'H'.
