### Message from Mayor and Council

After a two-year hiatus, Council enjoyed gathering in Memorial Park to celebrate Canada Day . . . and eating cake! Ongoing global events only emphasize how much we have to be grateful for, including the generosity of Indigenous hosts who share land with those of us who—as newcomers or through ancestral immigration—have chosen to live in Canada. Our thanks to the Summerland Legion for organizing the Canada Day celebrations.

Downtown Vibrancy is one of six key themes in Council's 2018-2022 Strategic Plan; one of the initiatives that falls under this theme is the creation of a Downtown Neighbourhood Plan to provide a long-term vision for the future growth and development of the downtown neighbourhood. Following a call out to community members to participate on the Downtown Neighbourhood Plan Task Force, members were appointed in November 2020. Following 17 months of work, the draft Downtown Neighbourhood **Action** Plan was presented to Council on June 13. Thank you to the 12 steadfast members of the Task Force, District senior management and Urban Systems for your commitment in creating this draft Plan.

The draft Plan is now out for community engagement for your questions, comments and/or concerns. More information is available elsewhere in this newsletter with links to the draft document and how you can let us know your thoughts. Council is looking forward to the implementation of the Downtown Neighbourhood Action Plan, recognizing this is a project that will be underway for many years.

#### **Property tax notices**

The 2022 Property Tax due date was **July 4**, **2022** at **4:00 PM**. Effective July 5, 2022 unpaid 2022 Property Taxes (including unclaimed Home Owner Grants) are now subject to a 10% penalty.

You may still claim the HOG online at <u>www.gov.bc.ca/homeownergrant</u> or phone the Province of BC **1-888-355-2700**. Retroactive home owner grant applications are accepted up until December 31<sup>st</sup> each year.

The District of Summerland offers a Pre-Authorized Payment Program for property taxes - eleven (11) equal payments will be withdrawn from your bank account, starting August 15th each year. The final twelfth (12th) payment will be the difference between the actual amount of the current tax bill and prepayments collected, plus interest earned up to the tax due date.

# Sewer main and hydrant flushing

The District of Summerland is performing annual sewer main and hydrant flushing throughout Summerland until the end of October. Annual maintenance ensures that sewer mains and hydrants are working properly. Please use caution when driving by crews working on the road.



# New regulations for dogs in parks

The Parks Regulation Bylaw (2022-012) has been updated to permit dogs in parks under the following terms <u>except</u> on sports fields, sport courts, skateparks and beaches, or near playgrounds and spray parks:

- Dogs are permitted on-leash year-round at Memorial Park, Dale Meadows Park, Living Memorial Park, Peach Orchard Beach Park, Powell Beach Park, Peach Orchard Campground, Giant's Head Park, Conkle Mountain Park, Cartwright Mountain and Summerland Rodeo Grounds.
- Dogs are permitted off-leash during the off-season (October 1 May 1) at Peach Orchard Beach Park, Powell Beach Park, Peach Orchard Campground, Conkle Mountain Park, Cartwright Mountain and Summerland Rodeo Grounds (except around equestrian events and activities).
- Dogs are permitted off-leash year-round only at designated District off-leash dog parks.

Construction for the Canyon View Road watermain project was completed in the middle of June. The project included 1,050m of watermain replacement and road reconstruction on Canyon View Road, Paradise Road, and McGee Street from Simpson Road to Mountain Avenue.



# Agricultural User Meter Readings

Agricultural users are reminded that monthly meter read updates are available on the municipal website. Now that the weather is becoming hotter, users should review their consumption more closely. To access these reports, please go to the District of Summerland's website at <u>www.summerland.ca</u>. Under the "City Services" tab at the top of the page, click "Agricultural Water" to be taken to the appropriate page. Additional information pertaining to agricultural water, such as 2022 rates, can also be found on this webpage. Irrigators are encouraged to view the data to track their usage. The annual irrigation invoice will be mailed out by the end of July.

#### Invasive plant alert—Burdock

Burdock is an invasive biennial plant introduced from Eurasia. The leaves of first year plants resemble rhubarb. It reaches heights of 1 – 3 metres with purple flowers from July to September found in shortstalked clusters along the stems. Mature plants have prickly burrs that stick to clothing or animals. Burdock's clinging properties



provide an excellent mechanism for seed dispersal. Fun fact: Burdock's clinging properties led to the invention of Velcro! The burrs can be a problem for livestock and wildlife. Birds and bats are stuck to seedheads and cannot fly away. If you have this invasive plant on your property, take action. Repeated hand-pulling, digging, above ground cutting of bolted plants and chemical treatments can help control outbreaks.
