RE: Public Hearing Report - Amendment Bylaw Nos. 2603.16 and 2455.39, 2018

Purpose of Bylaw:

The purpose of Amendment Bylaw Nos. 2603.16, 2018 and 2455.39, 2018, to implement the Okanagan Falls Town Centre Plan (2017) as it relates to the Electoral Area "D" Zoning Bylaw.

Specifically, the amendments to the Electoral Area "D" Zoning Bylaw No. 2455, 2008, propose to apply a new "Okanagan Falls Town Centre (OFTC)" Zone to those parcels of land generally situated north of Highway 97 in Okanagan Falls between the Okanagan River Channel to the west, Skaha Lake to the north and Main Street to the east. This new OFTC Zone will, amongst other things:

- · expand the range of permitted uses;
- eliminate the requirement for the provision of ground floor retail/commercial uses currently mandated by the C4 and CT1 zones;
- establish a minimum residential density of 40 units/parcel;
- establish a maximum residential density of 100 units/ha;
- apply a minimum parcel size for subdivision of 1,000 m²; and
- apply a maximum building height of 15.0 metres.

The proposed amendments to the Electoral Area "D" Official Community Plan (OCP) Bylaw No. 2603, 2013, is to introduce policy statements supporting the proposed density of 100 units/ha as well as supporting proposal to increase height in the OFTC between 8th and 9th Avenues, subject to the provision of affordable housing, community infrastructure or the provision of other community benefits.
