B. DEVELOPMENT SERVICES – Building Inspection

B.1 3548 Fruitvale Covenant Contravention

Jessie Parsons, Admin Operations Assistant at property in question was present to speak to the Board on this matter.

MOVED and SECONDED

THAT remedial action be commenced against the owners of 3548 Fruitvale Way, Oliver if by June 19, 2023 the property is not in compliance with Zoning Bylaw 2800, Building Bylaw 2805 and Statutory Covenant LB321583 registered against the property.

THAT the Regional District seek to recover the costs of undertaking the above legal action from the owner in the same manner and with the same remedies as property taxes in arrears.-CARRIED
