The RDOS would like your comments by November 12, 2025 regarding two recently submitted variance applications for the use of holding tanks as a method of on-site sewage disposal at 4535 and 4545 Mill Road.

These properties were the subject of previous variances E2022.058-DVP and E2022.059-DVP for the same purpose, which were approved by the Regional Board. These permits lapsed due to delays associated with other provincial approvals, and the applicant is seeking re-approval of the lapsed variances.
