GENERAL CONDITIONS

- 1. This Development Variance Permit is issued subject to compliance with all of the bylaws of the Regional District of Okanagan-Similkameen applicable thereto, except as specifically varied or supplemented by this Permit.
- 2. The land described shall be developed strictly in accordance with the terms and conditions and provisions of this Permit, and any plans and specifications attached to this Permit that shall form a part thereof.
- 3. Where there is a conflict between the text of the permit and permit drawings or figures, the drawings or figures shall govern the matter.
- 4. This Development Variance Permit is not a Building Permit.

APPLICABILITY

5. This Development Variance Permit is substantially in accordance with Schedules 'A' and 'B', and applies to and only to those lands within the Regional District described below, and any and all buildings, structures and other development thereon:

CONDITIONS OF DEVELOPMENT

- 6. The land specified in Section 5 may be developed in accordance with the following variances to the Subdivision and Servicing Bylaw No. 2900, 2024, in the Regional District of Okanagan-Similkameen:
 - a) Where all new parcels created by subdivision must be provided with sufficient disposal of on-site sewage, as prescribed in Section 4.2.1.1(b), is varied:

- i) from: requiring all new parcels less than 1.0 ha to be conenected to a community sewer system
- to: requiring all new parcels less than 1.0 ha to be provided with sufficient disposal of on-site sewage by an individual on-site sewage dispoal system.

EXPIRY OF PERMIT

- 9. The development shall be carried out according to the following schedule:

 - b) Lapsed permits cannot be renewed; however, an application for a new development permit can be submitted.


