This letter is to inform you that due to the current levels of internal capacity, we are unable to review your referral in your proposed timeline. With additional time, sməlqmix (Lower Similkameen Indian Band) will be able to ensure that an informed review process will occur. We are setting the new timeline to be 40 days from the existing timeline.

smelqmix/syilx (Okanagan Nation) Title includes the right to proactively use and manage our resources. In the Tsilqot'in, the Supreme Court of Canada emphasizes the need to seek the consent of the title-holding Aboriginal group, and warns, without consent of a project, the proponent risks having the project cancelled. The obligation to seek free, prior and informed consent is further required by the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP). UNDRIP requires that Indigenous peoples shall be consulted and cooperated with in good faith in order to obtain their free and informed consent prior to the approval of any project affecting their lands or territories and other resources, particularly in connection with the development, utilization or exploitation of mineral, water or other resources.

#### Hi Shannon.

While the portion of the property proposed for redesignation to SH is not in the Agricultural Land Reserve (ALR), it does appear to have soils that are mainly loam and sandy loam which are well suited for growing forage, which is what the property appears to be used for currently. Therefore, it does appear to have agricultural capability, although we have not been on site to evaluate the capability classification and provincial mapping does not show the capability classification for this area. We therefore do not recommend that the redesignation occur as the SH designation will allow for an increase in density and smaller lots that would limit the potential for the parcel to be used for farming in the future and may also increase the potential for farm practice complaints if the new lots are used for rural residential development.
