
Anyone who considers themselves affected by the amendment bylaws can present written information to the Regional District prior to or at the public hearing and may also speak at the public hearing. No letter, report or representation from the public will be received after the conclusion of the public hearing.

PURPOSE OF THE BYLAW(S):

The purpose of the proposed amendments is to facilitate a 10-lot bareland strata subdivision. More specifically:

Amendment Bylaw No. 2497.13, 2022, proposes to amend Schedule 'B' (OCP Bylaw Map) of the Electoral Area "H" OCP Bylaw No. 2497, 2012, by changing the land use designation of 240 Lawless Creek Road (which is legally described as District Lot 1020, YDYD), from from Large Holdings (LH) to Small Holdings (SH).

Amendment Bylaw No. 2498.24, 2022, proposes to amend Schedule '2' (Official Zoning Map) of the Electoral Area "H" Zoning Bylaw No. 2498, 2012, by changing the zoning of 240 Lawless Creek Road (which is legally described as District Lot 1020, YDYD), Large Holdings Two (LH2) to Small Holdings Three (SH3).
