### CONDITIONS OF DEVELOPMENT

- 6. The land specified in Section 5 may be developed in accordance with the following variances to the Okangan Valley Zoning Bylaw No. 2800, 2022, in the Regional District of Okanagan-Similkameen:
  - a) the minimum front parcel line setback for an accessory building in the Low Density Residential Two (RS2) Zone, as prescribed in Section 16.2.5(b)(i), is varied:

i) from: 7.5 metres

to: 0.0 metres to the outermost projection as shown on Schedule 'B'.




