- i) That Lakeshore Highlands be named in the list of examples of rural-residential areas on page 10, paragraph 3 of the draft amendment bylaw

- i) That Policy 3D-3 be amended to read as follows:
Supports the development of an integrated active transportation (cycling, walking, scooters, etc.) network and connections in Growth Areas, Village Settlement Areas and Resort Areas. With the exception of development in any federal or provincial wildlife sanctuaries that specifically protect species at risk. 2 in favor. 2 opposed.
