RE: Okanagan Valley Official Community Plan (OCP) Bylaw (X2025.007-ZONE)

Administrative Recommendation:

THAT the Okanagan Valley Official Community Plan Bylaw be initiated as part of the ongoing Regional Growth Strategy (RGS) Bylaw Review;

AND THAT the following items be considered for inclusion on the 2027 Strategic Priority Work Plan:

- **Conservation Area (CA) Zone Review;**
 - **Naramata Village Centre (NVC) Zone Review;**
 - **Okanagan Falls Development Permit Area Review; and**
 - **Local Area Policy Review.**

Purpose:

The purpose of this report is to outline options for proposed revision to the draft Okanagan Valley Official Community Plan (OCP) bylaw.

Strategic Priorities: Operational

Legislative Requirements:

Under Section 445 of the *Local Government Act*, “all bylaws adopted by a regional district board after the board has adopted a regional growth strategy, and all services undertaken by a regional district after the board has adopted a regional growth strategy, *must* be consistent with the regional growth strategy.”

In addition, under Section 478 of the Act, all bylaws enacted or works undertaken by a Regional District Board after the adoption of an official community plan *must* be consistent with that plan.

Background & Analysis:

At its meeting of November 17, 2022, the Planning and Development (P&D) Committee considered a proposal to consolidate the six (6) Okanagan Electoral Area OCP Bylaws into a new Okanagan Valley OCP Bylaw and resolved that this be undertaken as a strategic project.

At its meeting of September 4, 2025, the P&D Committee was presented with a draft version of the Okanagan Valley OCP bylaw and considered a proposal to complete this project as part of the ongoing Regional Growth Strategy (RGS) Bylaw Review.

The Committee subsequently resolved that a workshop for the RGS Bylaw Review and the Okanagan Valley OCP Bylaw be scheduled prior to Board initiation of the project.

In response, a copy of the draft Okanagan Valley OCP Bylaw was circulated to the Electoral Area Directors for review in order that comments could be provided for discussion at a workshop. A summary of comments received is included at Attachment No. 1 to this report.

On October 16, 2025, a workshop on the Okanagan Valley OCP was held during the meeting of the P&D Committee.

The P&D Committee moved and seconded to not initiate the Okanagan Valley Official Community Plan Bylaw, and resolved that consideration of this motion be deferred until after a workshop for the Directors is conducted.

Following the October 16, 2025, P&D Committee, additional comments on the Okanagan Valley OCP were received in relation to Electoral Area "D". These comments have been included at Attachment No. 1 to this report.

Analysis:

In considering the comments provided by Electoral Area Directors, Administration notes a majority of these were minor in nature and have been incorporated into an updated draft of the Okanagan Electoral Area OCP Bylaw. This includes:

- Adding a new policy supporting the provision of attainable housing under Section 4.3.2 (Policies – Regional Housing Needs);
- Revising an existing policy under Section 5.10.5 (Policies – Social Well-Being) to specifically support the use of lands designated Administrative, Cultural and Institutional (AI) for sporting events and non-profit fundraisers;
- Revising an existing policy under Section 7.11.2 (Policies – Lower Naramata) supporting the re-designation of the Naramata Centre to specifically include a community centre;
- Revising existing Dark Sky policies in Section 7.11.2 (Policies – Lower Naramata) and Section 7.11.3 (Policies – Upper Naramata) for improved clarity; and
- Adding a new policy under 7.11.2 (Policies – Lower Naramata) encouraging the Ministry of Transportation and Transit (MoTT) to retain alleyways for active transportation purposes.

New Strategic Projects

Other requests are beyond the scope of the current project and are best addressed through the planning process for the annual Strategic Priorities Work Plan, including:

- Conservation Area (CA) Zone Review;
- Naramata Village Centre (NVC) Zone Review;
- Okanagan Falls Development Permit Area Review;
- Local Area Policy Review.

Financial Implications:

Reducing the number of Okanagan Electoral Area OCP Bylaws from six (6) to one (1) is estimated to result in a potential cost savings of \$650,000 to \$750,000 over the next 15-20 years.

In addition to these costs savings, staff time should be freed up to work on additional Board strategic priorities other than OCP Reviews.

Communication Strategy:

A formal “consultation plan” will be brought forward at a forthcoming meeting of the Board in relation to the proposed RGS Update and Okanagan Valley Electoral Area OCP Bylaw, and once the final scope of these projects has been confirmed by the Board.

Alternatives:

1. THAT the Okanagan Valley Official Community Plan Bylaw, be revised as follows:
 - a) *TBD*
2. THAT the Okanagan Valley Official Community Plan Bylaw not be initiated.
