BYLAW NO. 2800.61, 2026

A Bylaw to amend the Okanagan Valley Zoning Bylaw No. 2800, 2022

The REGIONAL BOARD of the Regional District of Okanagan-Similkameen in open meeting assembled, ENACTS as follows:

1. This Bylaw may be cited for all purposes as the “Okanagan Valley Zoning Bylaw Amendment Bylaw No. 2800.61, 2026.”
2. The “Okanagan Valley Zoning Bylaw No. 2800, 2022,” is amended by:
 - i) adding a new reference to “Schedule ‘3.2’ - Park Rill Creek, Horn Creek and Kearns Creek Floodplain Maps” under Section 1.2 (Application) at Section 1.0 (Title and Application) following the reference to “Schedule ‘3’ – Provincial Floodplain Maps”.
 - ii) adding a new sub-section 10.1.1(b) under Section 10.1 (Floodplain Designation and Flood Construction Level) to read as follows and renumbering all subsequent sections:
 - b) the area shown as the 200-year *floodplain* for Park Rill Creek, Horn Creek and Kearns Creek on the floodplain map attached as Schedule ‘3.2’ to this bylaw;
 - iii) adding a new sub-section 10.1.2(b) under Section 10.1 (Floodplain Designation and Flood Construction Level) to read as follows and renumbering all subsequent sections:
 - b) the 200-year flood levels shown on the Park Rill Creek, Horn Creek and Kearns Creek floodplain maps for the *floodplain* designated in section 10.1.1(b);
 - iv) adding a new sub-section 10.2.3 under Section 10.2 (Siting Buildings and Structures in Floodplains) to read as follows and renumbering all subsequent sections:
 - .3 15.0 metres of the natural boundary of Park Rill Creek, Horn Creek and Kearns Creek;

- v) adding a new Schedule 3.2 (Park Rill Creek, Horn Creek and Kearns Creek Floodplain Map) as shown on the attached Schedule 'A' (which forms part of this bylaw).
