The Regional District of Okanagan Similkameen is Tendering for the Solids Processing Upgrade for the Okanagan Falls Wastewater Treatment Plant.

There will be a Mandatory Pre-Tender Meeting Thursday, March 11th at 1:30 pm at the Okanagan Falls Wastewater Treatment Plant located at 300 Rail Road (map coordinates: 49.324811, -119.567629). More detailed viewing of the existing interior space will be accommodated where possible. To help with social distancing, a maximum of two individuals from each Contractor will be allowed to attend.
