

# 2022 APPLICATION FOR MOBILE FOOD VENDING LICENSE

Definition: "Food Truck" or "Hitched Trailer" means a food truck or mobile trailer from which food and/or drink is prepared internally and dispensed externally and parked on locations permitted by the Regional District. Food truck locations can accommodate trucks up to 24' in length. Food trucks exceeding 24' are limited to "Hitched Trailer" locations only.

- Having a proposed vendor location or products which is perceived to present a safety hazard or risk;
- Sale of items that are not noted in this document or approved in writing by the Regional District;
- Unprofessional or inappropriate vendor conduct including, but not limited to, illegal activities, consumption of alcohol or drugs, use of profane language, actively soliciting or harassing pedestrians walking by, or smoking within the vendor area;
- Failure to adhere to permitted vending locations

Any illegal activities at the location will result in immediate termination of your mobile vending License and will be dealt with by RCMP.

Other than location issues, which will be monitored by Regional District bylaw enforcement, the Regional District will not become involved in issues arising between vendors, and supports fair competition in a free and open market place. Please resolve any issues that may arise yourselves.

### 3. Required Documents/Information

Applicants must submit the following.

- Completed application for Mobile Food Vending
- Signed Mobile Food Vending Agreement

The vending season will run from April to October each year. Applications can be submitted at any time; however, vending spots will mainly be based on first come, first served. You are encouraged to submit your application early in the season. Incomplete applications will not be considered.

#### 4. Fees and Locations

The Mobile Food Vending License fee is \$500.00 + GST per season (April-October).

Vendors are required to supply their own power at their desired location. Alternatively, power can be accessed, if available at the particular location, for a fee of \$5.00 per day.

Listed below are all acceptable locations for mobile food vendors, along with their amenities.

### 5. Awarding of Mobile Food Vending Licenses

Mobile Food Vending Licenses will be awarded based on, but not limited to:

- Returning vendors in good standing
- Local residents
- Consideration of previous vending agreements with the RDOS
- Consideration of proximity to direct competition operating from a building and impact on neighbourhood
- Visual appearance of the vending truck/trailer

All those applying will be notified by email as to the outcome of the selection process. Notification shall mean that the City has attempted contacting the notification contact email provided in this application.

Being the first year of this application process, applications will be accepted throughout the year.

Applications in 2023 will be accepted from April to May and then closed for the remainder of the year.

Once the successful applicant has been notified, the applicant must submit all items listed below including payment to the RDOS on or before the time indicated in the acceptance message. If inspections or WCB coverage has not been completed in this timeframe, please provide email copies of appointment requests and inquiries. No Licenses shall be issued until all required items have been received and processed. Please advise if you will not be able to provide documentation and payment by the time requested due date.

Required items: \*please note that these requirements are ALL required ANNUALLY

Insurance must in place prior to issue of License. There will be no exception to the insurance requirements.

Mobile Food Vending License Fee



■ Liability Insurance confirmation from the Insurer named the Regional District of Okanagan-Similkameen as an additional insured for the amount of not less than five million (\$5,000,000) dollars. The policy to include the following clauses:

## "Cross Liability" clause:

"The insurance afforded by this policy shall apply in the same manner, as though separate policies were issued, to any action brought against any of the named insured by or on befhalf of any other named insured."

#### "Cancellation" clause:

"It is understood and agreed that the coverage provided by this policy will not be changed or amended in any way or cancelled until thirty (30) days after written notice of such change or cancellation shall have been given or sent by registered mail to all Named Insured."
