



## RESIDENTIAL WATERING RESTRICTIONS FOR SYSTEM USERS

### STAGE NORMAL

The Regional District of Okanagan-Similkameen reminds Naramata water system customers that **Stage Normal** watering restrictions are in effect year-round or until situations change.

**Even numbered properties** → **Tuesday, Thursday and Saturday**

**Odd numbered properties** → **Wednesday, Friday, and Sunday**

Watering Established Lawns, Shrubs/Flowers	Newly Planted Sod, Trees or Flowering Shrubs	Outdoor Cleaning	Topping Up/ Refilling Pools, Hot Tubs, Ponds or Water Features
<p><u>Manual Sprinklers:</u> <b>3 days per week</b> <b>6:00 AM to 10:00 AM</b> <b>6:00 PM to 10:00 PM</b> <b>On your watering day</b></p> <p><i>No sprinkling on Mondays</i></p>	<p><u>Seeded Lawns or Turf:</u> Any day at any time using any method for the first 49 days after installation of seeded lawns</p>	<p><u>Driveways, Sidewalks, Patios and Decks:</u> Any day, using any method provided it does not result in *Excess Water Use</p> <p><i>It is suggested to use a broom, or hose with spring loaded shut off nozzle</i></p>	<p><u>Maximum Volume:</u> 4,000 litres/ day</p> <p><u>No Time Restrictions:</u> Any day, any time</p> <p><b>Note:</b> for a single filling volume above 40,000 litres, 24-hours notice must be provided to the RDOS</p>
<p><u>Automated Irrigation Systems:</u> <b>12:01 AM to 6:00 AM</b> <b>On your watering day</b></p>	<p><u>Trees and Flowering Shrubs:</u> Any day at any time using any method for 21 days after planting of new trees and flowering shrubs. Stage 1 restrictions are required after 21 days</p>	<p>*Excess water use is defined as applying more water than is required to provide a service, produce a product, or complete a task</p>	<p><b>Please Let us Know When You Re-Fill Your Pool</b></p>
<p><b>Hand watering of flower and vegetable gardens is allowed daily; drip or handheld</b></p>	<p><b>Stage 'Normal' represents normal conditions for the local area and your water system. Water Restriction Stages are important to conserve water, minimize pumping costs and maintain adequate volumes (flow) for fighting fire.</b></p>		

# Helpful Reminders Enclosed

The RDOS has created two, helpful items to make it easy to follow residential sprinkling regulations

The 4" x 6" magnet can be placed on a fridge or any metal surface like a filing cabinet or even some exterior doors. Place the magnet where it will cue occupants to adhere to sprinkling regulations and if applicable, to insure automatic timers are set correctly.

year round unless notified

Hand held garden hose  
up to Stage 2 any day, anytime

**NO watering on Mondays**

**STAGE NORMAL WATERING SCHEDULE:**

**EVEN** numbered civic address **TUE THU SAT** 6-10am & 6-10pm

**ODD** numbered civic address **WED FRI SUN** 6-10am & 6-10pm

**AUTOMATIC residential irrigation:**  
12:01am to 6am on your watering day

The 2" x 3" plastic reminder is for the most used outdoor faucet, where the hose attaches – known as a hose-bib. The envelope will contain a zap-strap to help secure it to the shaft of the faucet.
