

## EVACUATION ORDER RESCIND - August 19, 2023, 1000 hrs Crater Creek Wildfire

The **EVACUATION ORDER**, Pursuant to Section 13 (1) of the *BC Emergency Program Act* issued by the Regional District of Okanagan-Similkameen on August 17, 2023 at 1615 hrs is **RESCINDED**.

The **Order RESCIND** is in effect for the following:

- Electoral Area “G” along the Similkameen River on the west side of Highway 3 from 3675 Highway 3 to 4355 Highway 3.
- This area includes: Suncatchers RV Park; Riverside MH Park; and Lucky R MH Park.

An Evacuation Alert will be issued for these properties; and if it is deemed necessary, the Evacuation Order process will re-commence.

### WHAT YOU SHOULD DO:

- Fill the gas tank of personal vehicles.
- Bring a minimum of three days of food and essential supplies (local grocery stores may not yet have adequate stock):
  - medications
  - pet supplies
- If your animals or livestock have been relocated, to coordinate their safe return call:
  - **Animal Emergency Response Team (ALERT): 250-809-7152 – Pet owners and hobby farmers**
  - **RDOS EOC: 250-490-4225 – Commercial Farmers**




