## Evacuation Alert RESCINDED – August 25, 2023, 1300 hrs Crater Creek Wildfires, K52125

The Evacuation Alert issued by the **Regional District Okanagan-Similkameen** in Electoral Area “G”:

- From 10<sup>th</sup> Avenue and Highway 3 along the west/south side of Highway 3; to the Lower Similkameen Indian Band boundary.
- From 3175 River Road going west along River Road and north to the Similkameen River; travelling to 205 Ashnola Road.
- Along the east/north side of Highway 3 from the Lower Similkameen Indian Band boundary up to 4354 Highway 3.
- Properties past 4354 Highway 3 on both sides of Highway 3 up to but not including 4625 Highway 3.

That was issued on August 17, 2023, 1845 hrs is **RESCINDED** for the list of properties in **Schedule 1**.

An Evacuation Alert may need to be reissued; however, if that is deemed necessary, the Evacuation Order process will re-commence.

### WHAT YOU SHOULD DO:

- Fill the gas tank of personal vehicles.
- Bring a minimum of three days of food and essential supplies (local grocery stores may not yet have adequate stock):
  - medications
  - pet supplies
- If your animals or livestock have been relocated, to coordinate their safe return:
  - **Pet owners and hobby farmers:**
    - Animal Emergency Response Team (**ALERT**): 250-809-7152
  - **Commercial Farmers:**
    - RDOS EOC: 250-490-4225

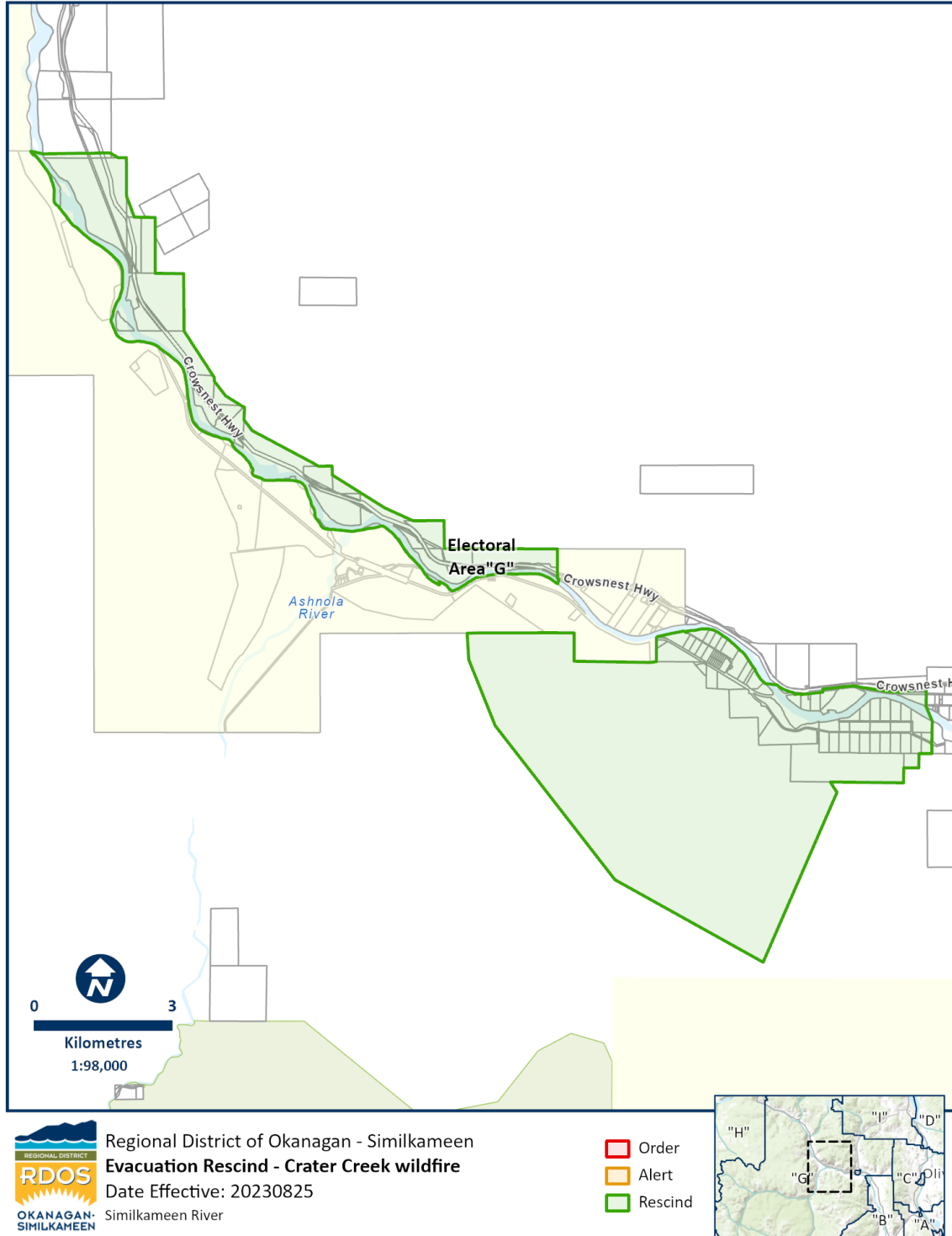
