BC WILDFIRE SERVICE AREA RESTRICTION ORDER Nk'Mip Wildfire (K52061)

Under Section 11(1) of the *Wildfire Act*, and pursuant to the authority delegated to me by the Minister of Forests, Lands, Natural Resource Operations and Rural Development, to address a public safety concern arising from the Nk'Mip Wildfire (K52061) and in order to avoid interference with fire control, I, Kaitlin Baskerville, Fire Centre Manager, hereby designate the area described below as a restricted area.

Under this Order and section 11(2) of the Wildfire Act, a person must not remain in or enter the restricted area without the prior written authorization of an official designated for the purposes of the Wildfire Act, unless the person:

Enters the area only in the course of:

- (a) Travelling as a person acting in an official capacity;
- (b) Travelling for the purpose of supporting wildfire suppression activities;
- (c) Travelling to or from his or her principle residence, that is not under an evacuation order;
- (d) Travelling to or from private or leased property for the purposes of accessing a secondary residence or recreational property, that is not under an evacuation order;
- (e) Using a highway as defined in the Highway Act; or,
- (f) Engaging and/or participating in agricultural activities pertaining to livestock or agriculture management on Crown Range, Crown Grazing Lease, private or leased property.

This Order applies to Crown land within the geographic boundaries described below and as outlined in heavy black dotted and shaded grey line on the attached map:

Western Boundary: Commencing at Point #1 (W 119° 25.84'; N49° 02.28'), where Highway 3 meets the Osoyoos Fire Department Boundary, follow the boundary west to the intersection with Osoyoos Lake natural shoreline (Point #2: W119° 26.69'; N49° 02.24'). Continue north along the shoreline to the intersection of Osoyoos Lake shoreline and Osoyoos 1 Indian Reserve boundary (Point #3: W119° 30.76'; N49° 04.63'). Continue north along the western boundary of Osoyoos 1 Indian Reserve until



it intersects with the Oliver Fire Department boundary (Point #4: W119° 31.05'; N49° 14.45).

Northern Boundary: Commencing at Point #5, travel east along Vaseau Creek to where it meets Conkel East Creek Forest Service Road (FSR) (Point #6: W119° 14.26'; N49° 15.37'), then travel east along the Conkel East Creek FSR until it meets Ripperto FSR (Point #7: W119° 06.17'; N49° 13.25').

Eastern Boundary: Commencing at Point #7, continue south, then east along Ripperto FSR to the intersection with Conkle Johnston Creek FSR (Point #8: W119° 05.44': N49° 11.49'), then travel east and south along the FSR until it meets the BC Hydro Transmission Line right of way (Point #9: W119° 02.65'; N49° 09.12').

Southern Boundary: Commencing at Point #9, travel in a westerly direction along the BC Hydro Transmission Line right of way to the intersection with Baldy Road Permit Resource Road (Point #10: W119° 19.07'; N49° 07.22'). Take a bearing at 180 degrees and travel 12.91 km to Highway 3 (Point #11: W119° 19.07'; N49° 00.26'). Continue west along Highway 3 to Point #1.

This Order takes effect at 12:00 noon Pacific Daylight Time (PDT) on August 7, 2021 and remains in force until the earlier of 12:00 noon (PDT) on October 15, 2021 or until the Order is rescinded.
