## Administrative Recommendation:

THAT the Regional District of Okanagan-Similkameen 2021 Schedule of Board and Committee Meetings, be approved as presented.

#### **Purpose:**

To establish, by resolution, a schedule for regular Board and Committee meetings for 2021 in accordance with relevant legislation and the RDOS Procedure Bylaw.

#### **Reference:**

Local Government Act RDOS Procedure Bylaw 2620, 2013

#### Analysis:

Generally, the Board follows a schedule of convening meetings on the first and third Thursday of each month; although, on occasion, those dates have been adjusted due to conflicts with annual conventions or proximity to the holiday season.

The 2021 Local Government Leadership Academy (LGLA) forum takes place virtually on February 3 and 4. This does conflict with the Board meeting of February 4; however, in past the RDOS has not attended LGLA in significant numbers and it was thought that Alternates would attend the Board meeting in the absence of any Director attending LGLA.

The 2021 Federation of Canadian Municipalities (FCM) convention is unconfirmed at this time, with proposed dates of either June 3-6 or June 10-13. In recent past only one Director has attended the FCM conference in person; however, if the conference is conducted virtually it is reasonable to expect that more Directors would take part. It is recommended that the normal Board meeting schedule remain in place for the time being, with an option to adjust those June meetings closer to the confirmed FCM date.

The Board may wish to consider adjusting the July dates to take place on July 8 and July 22, 2010, as a result of the July 1, 2020 Canada Day Statutory holiday. Because there are five Thursdays in the month of July, this adjustment would ensure that there are not two meetings held back to back. The regular schedule of first and third Thursdays would resume in August.

A further consideration could be the adjustment of the second meeting in September from the 16<sup>th</sup> to September 23<sup>rd</sup> which will facilitate the UBCM Convention, scheduled for 13<sup>th</sup> to the 17th. Because there are five Thursdays in the month of September, this adjustment would ensure that there are not two meetings held back to back. The regular schedule of first and third Thursday would resume in October.
