Dear Matt Taylor:

I am writing to thank you and your staff for taking the time to meet with me at this year's UBCM Convention in Vancouver, and to recap the topics discussed and commitments made at our meeting.

I am pleased we had the opportunity to discuss short-rayed Alkali Aster (SRAA) at length. During our meeting we heard your concerns about the negative perception of tourists and residents alike, due to the local beach looking unkept, based on the growth of SRAA. We discussed the possibility of reducing the SRAA footprint; identifying better ways to maintain the area and refreshing interpretive signage as possible solutions.

We commend the measures that Okanagan Falls has taken to maintain the federally-designated habitat for the SRAA. As mentioned, the work by Okanagan Falls led to the number of plants flourishing over the past fifteen years, from an estimated 15 to 1,000 plants. We agree that this deserves further consideration, and we will work with the Regional District of Okanagan-Simikameen and Environment and Climate Change Canada on possible next steps.

Additional concerns were raised regarding silt and milfoil in Vaseux and Skaha Lake; and it was speculated that a reduction in milfoil harvesters was linked to mussels and the Okanagan Basin Water Board policies. Deputy Minister Lori Halls and I are informed by staff that increased summer temperatures and extended summers have increased aquatic plant growth, including milfoil. It might be helpful to direct further questions regarding milfoil to the Okanagan Basin Water Board.

Since meeting in September, the Ministry of Water, Land and Resource Stewardship has become responsible for additional water, land, fish, and wildlife authorities. The attached
