

#### Accessible ramp to dike walking trail is complete!



The new ramp to the dike is now complete and ready for the community to enjoy. The gentle slope and easy-to-grip handrails make the ramp perfect for people of all abilities. The ramp features a second, lower railing for those with sight challenges to use as a navigation guide. The ramp was funded by the Village and a provincial Rural Dividend Program grant.

When walking on the dike, watch for the unique species of the Lower Similkameen. The Similkameen is one of few remaining wild rivers in the Southern Interior of British Columbia.

The river and shoreline habitat houses a wide variety of large and small mammals. The bunchgrass-sage and cottonwood-riparian stands support bird species on the current Red and Blue lists, as well as a number of at-risk reptile and amphibian species, including the Red-listed Tiger Salamander.

The Similkameen River supports native Rainbow Trout and Mountain Whitefish. It is also host to at least 15 other species of fish, including four on the provincial Red and Blue lists of endangered fish. The Similkameen River near Keremeos has unique side channel habitat which is important for spawning and juvenile-rearing.

Please take care not to disturb the ecoculture and always stay away from the riverbanks during periods of high water and high flow. Riverbanks can be undercut and slippery, looking safe when they are not!

## Could an emergency service find your address at night?



This evening after dark, take a walk past your property and see how visible your house numbers are. If you had to call police, fire or ambulance, could they quickly verify your address by looking at those house numbers?

Emergency services' GPS applications can get the services close to your home, but emergency personnel may have to look for your address numbers to be sure they are attending the correct location.

If you feel your house number visibility could improve, consider reflective, light-coloured numbers and placement in a lit area not obscured by foliage.

Seconds count in an emergency. Please help the first responders help you by ensuring that your house numbers are visible.

#### Thinking of running for Mayor or Councillor?

The next general election will take place on October 15, 2022. To run for Mayor or Councillor, you must be:

- ✓ be 18 years of age or older on general voting day
- ✓ be a Canadian citizen
- ✓ have been a resident of British Columbia for six months immediately prior to filing nomination documents
- ✓ not be disqualified under the Local Government Act or any other enactment from being nominated for, being elected to or holding office, or be otherwise disqualified by law
- ✓ nominated by at least two eligible electors

Nomination documents must be filed with the Chief Election Officer at the Village Office between August 30 at 9 am and September 9 at 4 pm.
