RE: Public Hearing Report - Amendment Bylaw No. 2800.09, 2022

Purpose of Bylaw:

The proposed amendment to the Okanagan Valley Zoning Bylaw No. 2800, 2022, is related to a proposal to use six agri-tourism accommodation sleeping units as opposed to the five currently permitted under the Zoning Bylaw.

Public Hearing Overview:

The Public Hearing for Bylaw No. 2800.09, 2022, was convened on Tuesday, May 31, 2022, at 7:00 pm, at https://rdos.webex.com (Meeting number: 2487 201 4160).
