Purpose of Bylaws:

The purpose of the proposed amendments to the Electoral Area "A", "C", "D", "E", "F", "H" & "I" Official Community Plan (OCP) Bylaws is to update the Watercourse Development Permit (WDP) Area designations in order to ensure consistency with the provincial Riparian Area Protection Regulation (RAPR).
