REGIONAL DISTRICT OKANAGAN-SIMILKAMEEN

BYLAW No. 2375, 2006

A bylaw to establish an Emergency Planning Program Service.

WHEREAS, pursuant to the provisions of the *Emergency Program Act*; being Chapter 111 of the Revised Statutes of British Columbia, and amendments thereto, a Board must establish local emergency plans that encompass the entire regional district; and,

WHEREAS approval of the electors in the participating municipal areas for the services established by this bylaw has been given consent in writing by the municipal councils in accordance with subsection 801.4 of the *Local Government Act*; and,

WHEREAS the Directors the Regional District have given consent on behalf of the electors of the Regional District to adopt this bylaw in keeping with Section 801.5 of the *Local Government Act*, being Chapter 323 of the Revised Statutes of British Columbia.

NOW THEREFORE, the Board of Directors of the Regional District Okanagan-Similkameen, duly assembled in an open meeting hereby enacts as follows:

CITATION

1) This bylaw may be cited for all purposes as "Regional District Okanagan-Similkameen Emergency Planning Program Service Establishment Bylaw No. 2375, 2006."

DESCRIPTION OF SERVICE

2) The Board of Directors hereby establishes a service to provide an emergency program under the Emergency Program Act within the boundaries of Electoral Areas A, B, C, D, E, F, G, H, Town of Oliver, Town of Osoyoos, Village of Keremeos, Town of Princeton, City of Penticton and the District of Summerland.

SERVICE BOUNDARIES

3) The boundaries of this service are the boundaries of Electoral Areas A, B, C, D, E, F, G, H, Town of Oliver, Town of Osoyoos, Village of Keremeos, Town of Princeton, City of Penticton and the District of Summerland.

SERVICE PARTICIPANTS

4) The participants in this service are Electoral Areas A, B, C, D, E, F, G, H, Town of Oliver, Town of Osoyoos, Village of Keremeos, Town of Princeton, City of Penticton and the District of Summerland.

COST RECOVERY

- 5) The annual costs of the service shall be recovered pursuant to Sections 803(1)(a) and (c) of the *Local Government Act* as follows by:
 - (a) the requisition of money in the service area, to be collected by a property value tax on the net taxable value of land and improvements within the service area, to be levied and collected in accordance with Division 4.3 of Part 24 of the *Local Government Act*,
 - (b) the imposition of fees or other charges that may be fixed by separate bylaw for the purpose of recovering those costs or,
 - (c) a combination of (a) and (b) above.
 - 6) Bylaw No. 2322, 2004 is herby repealed.
