REGIONAL DISTRICT OF OKANAGAN-SIMILKAMEEN

BYLAW NO. 1454, 1993

A Bylaw to establish a street lighting local service area in and for the Heritage Hills – Phase II subdivision within a portion of Electoral Area 'D'.

WHEREAS a regional district may, by bylaw, establish and operate a local service under the provisions of Part 24 of the <u>Municipal Act</u>;

AND WHEREAS the Regional Board of the Regional District of Okanagan-Similkameen has been requested to establish a local service for the purpose of providing street lighting for Heritage Hills – Phase II subdivision within a portion of Electoral Area 'D';

AND WHEREAS the Regional Board has received a sufficient petition under Section 801 of the Municipal Act requesting the establishment of the local service for street lighting and has waived the assent requirement;

AND WHEREAS the Director of Electoral Area 'D' has consented, in writing, to the adoption of this bylaw;

NOW THEREFORE, the Regional Board of the Regional District of Okanagan-Similkameen, in open meeting assembled, **ENACTS** as follows:

THE SERVICE

1. The Regional District of Okanagan-Similkameen hereby establishes within Electoral Area 'D' a local service for the purpose of providing street lighting within the boundaries of the service area shown outlined on the plan attached as Schedule 'A' to this bylaw and known as "Heritage Hills – Phase II & III Street Lighting Local Service Area"¹.

ANNUAL COSTS

2. The annual costs of providing the service established under Section 1 shall be recovered by the requisition of money under Section 804(1)(a) of the <u>Municipal Act</u> to be collected by a property value tax on land and improvements to be levied and collected under Section 810.1(1) of the <u>Municipal Act</u>.

3. The maximum amount that may be requisitioned to meet the annual operating costs for the service is an amount equivalent to no more than \$0.30 per \$1,000.00 of net taxable value of land and improvements included in the local service area.


